PROFESSIONAL FEE SCHEDULE

VALID MAY 1, 2009 THROUGH JUNE 30, 2010

Expert Witness Fees

1. Expert witness and deposition fee: **\$300.00 per hour**. One-hour minimum. Time rounded up to the nearest tenth of an hour. Travel and mileage is billed as outlined below. A **\$1000.00 cancellation fee** may be charged if cancellation occurs within two business days of the scheduled appearance date. If court appearance is by subpoena, one full day (8 hours) will be charged for each day the subpoena requires an appearance, regardless of the appearance time or length, or whether in fact an appearance is made, unless written cancellation of the appearance is received two weeks prior to the trial start date.
2. If Rudy Degger and/or any Associate employed by Rudy Degger & Associates, Inc., is disclosed as an expert witness, a flat **\$1000.00 expert witness disclosure fee**, or the actual work product fee, whichever amount is greater, will be charged.
3. In the event the party noticing a deposition fails to pay any portion of the required one-hour minimum or refuses to pay any portion of deposition time spent in excess of the required minimum, the party by whom RDA, Inc. is employed will be responsible for payment of that sum.

Accident Reconstruction Fees

4. All general research, calculations, reports, consultations, drawings, photography, inspections, travel time, electronic mapping, phone calls, meetings, clerical work, or other work product not specifically listed will be billed as follows with time rounded up to the nearest 0.1 hour:
 - a. All such services provided by **Accident Reconstruction Specialists** will be billed at **\$200.00 per hour**. Two-hour minimum.
 - b. Clerical work and all other technical support by **Clerical Staff** is charged at **\$75.00 per hour**. No minimum.
5. Mileage expense of 90 cents per mile. Expenses for air travel, lodging, food and other miscellaneous travel expenses during out-of-area travel will be calculated on a case-by-case basis.
6. A premium and/or additional charges will be added for the following:
 - a. Work required on the weekends and/or holidays: Saturday 100%, Sunday and holidays 200%.
 - b. A fee of \$500.00 per vehicle for all CDR retrieval in addition to the hourly fee stated above.
 - c. Miscellaneous work product fees are charged at actual costs.
 - d. Additional fees may apply for use of specialized equipment as decided upon a case-by-case basis.

Time billed will include all time expended, including preparation, court waiting, travel, etc. Payment is due upon receipt of invoice(s). We reserve the right to discontinue further work if invoiced balances are not paid within 90 days from the date of invoice. Balances not paid within ninety (90) days from the date of invoice will be subject to a service charge of two percent per month (24% APR).
